VLA's Legal Education Programs are a vital resource for the arts community and the lawyers who serve it. VLA offers foundational courses on legal fundamentals that apply across the arts and cultural sector as well as specialized classes addressing legal issues within individual creative disciplines.

In 2021, VLA continued to hold all educational programs virtually, both live and on-demand to ensure artists continued to receive support during the pandemic.

**Mixed-Income Earner Relief:** VLA worked with other VLA and entertainment organizations to secure the passage of this legislation and to educate our artists on it.




